I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Cray Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1: Arrangements for the approval of accounts The Council did not make proper arrangements for the approval of the Annual accounts. The Council did not approve the accounts by 30 June as required by the Accounts and Audit (Wales) Regulations 2014.
- Assertion 4: The Council did not make proper arrangements for the public inspection of accounts as required by the Accounts and Audit (Wales) Regulations 2014.

Other matters and recommendations

Typographical and rounding errors

There is a £1 rounding error in Line 7 of the accounts.

We recommend that before it approves the accounts each year, the Council ensures the consistency and arithmetic accuracy of the accounts.

There are no further matters I wish to draw to the Council's attention.
